If patient is exhibiting signs of shock - Keep warm and quiet.

Contact Poison Control Center immediately if necessary.

Do not administer liquids or induce vomiting to an unconscious or convulsing person. If patient is vomiting-watch closely to make sure airway does not become obstructed by vomit. Get medical attention if necessary.
